Forum Purpose

This forum will gather outstanding scholars from China and abroad to participate in an academic symposium and exchange to locate outstanding faculty who are eligible to be hired for the “1,000 Young Talents Plan” .

Guangzhou University

Mechanical Engineering, Electrical Engineering, Information and Communication Engineering, Control Science and Engineering, Computer Science and Technology, Software Engineering, Architecture, Landscape Architecture, Urban and Rural Planning, Civil Engineering, Transportation Engineering, Materials Science and Engineering, Electronic Science and Technology, Environmental Science and Engineering, Chemical Engineering and Technology, Mechanics, Mathematics, Biology, Astronomy, Geography, Physics and Chemistry.

Key Research Fields

Intelligent Manufacturing and Intelligent Business, Network Data Science, Urban Planning and Development, Urban Underground Space Development, Life Sciences and Human Health.

Qualifications

Applicants must hold PhDs from well-known universities from China and abroad specializing in natural sciences or engineering technology. Applicants should have scientific research experience overseas for more than 3 years in a row with achievements or strong academic potential in the identified fields. Applicants must declare their intention to participate in the “1,000 Young Talents Plan” .

Benefits and Compensation Package

Faculty hired for the “1,000 Young Talents Plan” are eligible for a great compensation plan which includes annual salaries ranging from 400,000 yuan (approximately \$58,130 USD) to more 1 million yuan (approximately \$145,300 USD), research start-up funding ranging from 500,000 yuan (approximately \$72,670 USD) to more than 1.5 million yuan (approximately \$218,000 USD), house purchase subsidies ranging from 1,200,000 yuan (approximately \$174,410 USD) to above 2 million yuan (approximately \$290,700 USD) or house-renting subsidies ranging from 3,500 yuan/month (approximately \$500 USD) to 5,000 yuan/month (approximately \$730 USD).

Application Process

(1) Domestic and foreign qualified scholars can register and fill out relevant information through the online registration system - <http://xzlt.gzhu.edu.cn>.

(2) Scholars invited to participate will receive their invitation letter from Guangzhou University by May 10.

(3) Scholars invited to participate must fill out the receipt and confirm their participation in the forum within one week of receiving their invitation letter.

Registration Deadline

The registration deadline is May 5, 2017.

Forum Travel and Accommodations

Guangzhou University will provide invited scholars with financial aid to include travel and accommodation expenses.

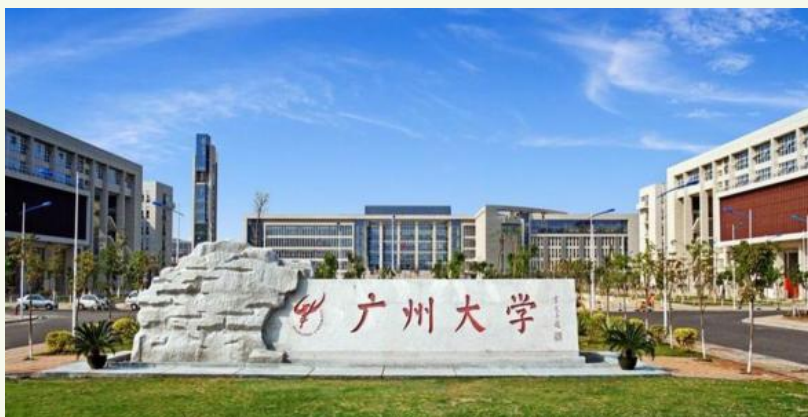
